**Subject: Implementation of suomotu disclosure under Section 4 of RTI Act, 2005 – Issue of Guidelines - reg.**

Reference is invited to ID Note no. R-11013/5/2025-RTI Cell dated 12.02.2025 of RTI Cell of this Ministry regarding the subject cited above wherein it has been requested to update the requisite information on the website of this Ministry.

2. In this regard, as far as B&A Section is concerned, the following documents are to be uploaded/updated on the website of this Ministry annually on suo motu basis:

a) Detailed Demands for Grants (DDG)-2025-26 [Bilingual]:

The DDG contains (i) Detailed Demands for Grants Media Units/Schemes/Autonomous Bodies-wise (this consists of Actuals of Financial Year 2023-24, Budget Estimates and Revised Estimates of the previous year and Budget Estimates of the ensuing year) (ii) Estimated Strength of Establishment and Provision therefor (iii) Statements showing the detailed provision Object-Head wise, (iv) Provisions in BE for payment of Grants-in-aid to Non-Government Bodies, (v) Details of individual works and projects costing 5.00 cr. or above, (vi) Statement showing particulars and nature of subsidies (vii) Statement showing contribution to International bodies and (viii) Monthly Expenditure Plan/Quarterly Expenditure Plan for the Financial Year.


b) Budget Overview-2025-26 [Hindi and English version]:

A Budget Overview of the Ministry has been indicated under this Head i.e. 'Budget Overview'. The total Budget of Ministry of Information & Broadcasting is categorized into three categories: (i) Establishment Expenditure of the Centre (ii) Centre Sector Schemes, (iii) Other Central expenditure (including Autonomous Bodies & PSU)

3. In this regard, it is stated that the aforementioned documents for FY 2024-25 have already been uploaded/updated on this Ministry's website.

4. In respect of point no. 24 of Annexure-II of the aforementioned I.D. Note dated 12.02.2025 of RTI Cell, it is submitted that CAG and PAC paras are directly handled by the concerned section/division in the Ministry. However this section (B&A) only monitors the same and uploads ATNs (as provided by concerned section/division) on the APMS portal. Further it is mentioned that no PAC paras are pending in r/o this Ministry. In r/o CAG paras, it is brought out that there are four (04) CAG paras relating to this Ministry and ATNs in r/o of all the four (04) CAG paras have been uploaded on the APMS portal and no action pending on the part of this Ministry at present. The latest position of CAG and PAC Paras in respect of this Ministry as per the APMS portal is placed as 'Annexure-I' and 'Annexure-II' respectively.
