In case of same L-1 rates, the successful bidder shall be chosen on the basis of distance from the office (Shastri Bhawan) - 50% weightage and the annual turnover (2024-25) of the respective dealer - 50% weightage. The bidder may submit requisite certified documents accordingly in this regard.
2. The quoted rates should be inclusive of all taxes/ GST as applicable.
