**OFFICE MEMORANDUM**

Subject: Filling up of 01 post of Production Manager (Printed Publicity)/Production Officer (Production) in the common cadre of Art and Production staff of CBC & DPD on deputation basis.

The undersigned is directed to say that this Ministry desires to fill up a post of Production Manager (Printed Publicity)/Production Officer (Production) {General Central Service, Group 'A', Gazetted, Non-Ministerial in the Pay Matrix Level-11 as per 7<sup>th</sup> CPC recommendation} in the common cadre of Art and Production staff of CBC & DPD, subordinate offices under this Ministry on deputation basis. The terms and conditions for the appointment to the post of Production Manager (Printed Publicity)/Production Officer (Production) are mentioned in **Annexure I.**

2. The period of deputation will be initially for a period of one year which may be extended at the discretion of the appointing authority. However, the period of deputation, including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government, shall ordinarily not exceed 3 years. The maximum age limit for appointment by deputation is **56 years** as on closing date of receipt of applications. The pay of the officer appointed on deputation basis shall be governed in accordance with the provisions contained in DoPT's O.M. No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010, as amended from time to time.

3. All Ministries/Departments are requested to circulate the vacancy and forward the application, complete in all respects, of the officers who fulfill the eligibility criteria and can be spared immediately in the event of their selection to the undersigned at Room No. 110, A-Wing, Shastri Bhawan, New Delhi – 110 001 in the prescribed proforma as at **Annexure-II**, in duplicate along with their up-to-date ACRs/APARs for the last 5 years within a period of **06 weeks** from the date of publication of this advertisement in the Employment News. While forwarding the applications, the Departments are requested to verify the entries made by the candidates in his/her bio-data, furnish an integrity certificate duly signed by an Officer not below the rank of Under Secretary to the Government of India or equivalent in addition to vigilance clearance and a certificate to the effect that no major/minor penalty was imposed on the officer during the last ten years.
