

**Minutes of the Meeting on ICH Single Window Facilitation Portal for Filming chaired by Secretary, Ministry of I&B held on 28.01.2026 at Akashvani Bhawan, New Delhi**

A meeting was held under the Chairmanship of **Secretary, Ministry of I&B** at 12.00 Noon on 28<sup>th</sup> January, 2026 (Wednesday) at Fielden Hall, 1<sup>st</sup> Floor, Akashvani Bhawan, New Delhi, to discuss issues relating to the India Cine Hub (ICH) Single-Window Portal for filming with Government stakeholders, including State Governments and concerned Central Ministries/Departments. The list of attendees is given in Annexure-I. Shri. Prithul Kumar, Joint Secretary, Ministry of Information and Broadcasting (MIB) welcomed Shri. Sanjay Jaju, Secretary, MIB, all senior officers/ delegates from Ministries, States & UTs.

Secretary, MIB emphasized the following key points in his inaugural address-

- 1.1. He outlined the founding objective and future vision of the India Cine Hub (ICH)— to facilitate both international and domestic filmmakers in using India as a destination and marketplace for pre- and post-production activities across all forms of creative storytelling. He also highlighted the upcoming expansion of the ICH Portal to cover live events, aimed at boosting the economy through simplified permission processes. States and UTs were requested to integrate with the portal and resolve any operational hurdles at the earliest.
- 1.2. He stressed the need for seamless two-way exchange of information and data between the ICH Portal and portals of States, UTs, and PSUs. Such integration would enhance ease of business and make the portal more attractive to filmmakers, noting that domestic usage of ICH remains limited.
- 1.3. Film productions, he noted, deliver dual benefits: economically, by generating employment and stimulating allied industries; and culturally, by providing national and international visibility when local sites are showcased on screen.
- 1.4. He asked the States to promote iconic filming locations, citing examples where popular films—both Indian and international—have driven significant tourism and employment by spotlighting such destinations.
2. Then JS(MIB) gave brief details of objective, status and future vision of ICH by stating that all kind of Clearances should be online and faceless from all Central/State/Local bodies/Trusts/PSUs and the Police etc. Then key features of the ICH were presented in the meeting by Shri Abhay of M/s Uneecops, the agency engaged for the revamp of the ICH portal, followed by discussion on agenda items. The copy of the presentation is given in Annexure II.
- 2.1. ICH is a single-window portal for both international and domestic producers to obtain permissions for filming in India, including clearances from ASI, States/UTs, and visa-related requirements. Producers can apply for any location across India through a Common Application Form. The portal covers permissions for live shoots (national and international), co-productions, animation, post-production, and documentaries. Statistical data on shooting applications for FY 2024–25 and 2025–26 was presented.
- 2.2. JS (MIB) noted that India has audio-visual co-production treaties with 17 countries, listed on the ICH portal. He explained that both filmic and non-filmic resources are

mapped on the portal and urged States/UTs to upload their local resources—such as line producers, crew, accommodation, and catering—so producers can easily access them and streamline production.

2.3. He further mentioned that ICH will soon adopt AI/ML tools to enhance user experience by suggesting suitable locations and nearby facilities. He emphasized the need for pre-approved shooting locations, which can be booked online with upfront payment to avoid delays.

2.4. States - It was noted that 7 States and 2 UTs with independent portals have already integrated with ICH. These States/UTs were further requested to upload permissions on the ICH portal to uphold its founding purpose.

2.4.1. The presentation highlighted that States/UTs marked in orange have their own portals which need to be unintegrated.

2.4.2. Shri Sanjay Jaju, Secretary (MIB) urged all stake holders to ensure early and full integration with ICH, including two-way exchange of payments, resources, schedules, and permissions to bridge all gaps.

2.4.3. And, States of Telangana, Karnataka, Uttar Pradesh, and Jharkhand agreed to proceed with full integration.

2.4.4. Gujarat cited technical issues with its portal but assured resolution soon. Himachal Pradesh reported that its new portal is under testing and will be released shortly.

2.4.5. Secretary (MIB) suggested that the State nodal officer for ICH should also serve as the nodal officer for live events, and States with this feature should integrate it promptly with ICH.

2.4.6. States may adopt time-bound approval mechanisms to enhance predictability and competitiveness. For example, Madhya Pradesh guarantees permissions within 15 days under its Public Service Act.

2.5. Railways - Shjri Dileep kumar, ED(IP), M/o Railways informed that all Railways filming permissions are routed through ICH. JS (MIB) proposed creating an ecosystem within ICH to cover multiple railway agencies, such as the Railway Protection Force, and suggested that Railways could accept MHA clearances instead of requiring fresh security approvals.

2.6. Defense - JS (MIB) urged the Ministry of Defence (MoD) to make its resources more accessible to filmmakers by adopting online system of ICH, for ensuring fair opportunities to all filmmakers for the domestic film ecosystem.

2.6.1. MoD informed that the permissions currently require approvals from multiple service-specific nodal points. Efforts are underway to establish a unified policy and single-window clearance system. At present, requests are processed through the Directorate of Public Relations (MoD), which routes them to service headquarters for security vetting and asset use. All three services' PROs will be on boarded onto the portal within about one month.

2.6.2. Availability will be assessed and provided on case-by-case, depending on requirements, location, and operational commitments.

2.6.3. MoD was requested that their permission process may made online accessible to the extent possible—from concept approval to script clearance, shooting

facilitation, and final preview—can be integrated into the ICH portal, ensuring transparency and a single-window, person-independent mechanism.

- 2.7. MHA- It was acknowledged that full online integration is not feasible currently. However, district-level police permissions (law and order, traffic management) for film shoots and live events can be digitized based on MHA and State guidelines. Since permissions often vary by district and officer, leading to last-minute disruptions, it was requested that MHA issue a clear advisory prescribing standardized procedures, defined timelines, and advance notice requirements. A uniform, time-bound framework would greatly ease filming operations and provide predictability.
- 2.8. MoEFCC - Director, MoEFCC stated that filming permissions in forests fall under State/UT jurisdiction. Integration with State forest departments via ICH could resolve this. JS (MIB) requested MoEFCC to issue an advisory to State authorities emphasizing uniform, time-bound procedures.
- 2.9. ASI / Ministry of Culture - ASI confirmed its integration last year, with 38 field offices handling domestic applications. However, ASI requested provision of an MIS/Dashboard at the DG (Delhi) level to enable effective monitoring and faster permissions.
- 2.10. JS (MIB) commended States that have adopted deemed approval provisions under citizen charters and urged others to follow this model, particularly for police and local authority permissions, to ensure predictability.
- 2.11. The State of Goa has explained through PPT about its pro filmic policies especially deemed approval time frame for permissions from all stakeholder departments.
- 2.12. Similarly, State of Telangana explained that all payments and permission is through their portal including refund and they also have time frame for all permissions.
- 2.13. The State of Chhattisgarh has also shown their portal and cited the upcoming projects incentives the creative economy.
- 2.14. However, States of Rajasthan emphasized that uniformity and seamless portal integration is crucial for promotion of Indian cinema and explained their policies of incentives.
- 2.15. State of Himachal Pradesh asked other central authorities like Ministry of Power/Water for onboarding as there are having authorities over many filmic locations like lakes, dams and other water bodies.
- 2.16. MIB appreciated the initiative taken by states and others to emulate their success stories.
- 2.17. Online Payments: It was agreed that all fees, charges, deposits, and refunds should be collected through a unified online gateway to ensure transparency and simplify reconciliation. Refunds and deposit returns should be automated and time-bound. An escrow mechanism was suggested, where funds are centrally collected and disbursed to departments, avoiding treasury-related delays.
- 2.18. Pre-Approved Locations: Each State should identify 5–10 filming locations with predefined SOPs and inter-departmental approvals, enabling filmmakers to shoot without repetitive clearances. This reduces lead time and encourages location-based filmmaking. The model is already being piloted for live event venues and stadiums.

SOPs should cover traffic thresholds, crew size limits, equipment norms, and safety conditions.

2.19. National Film Resource Directory: It was considered necessary for having a comprehensive directory of filmic and non-filmic resources on a single portal for India, including locations, studios, equipment, technicians, production services, catering, transport, healthcare, and logistics. Filmmakers expect unified discoverability, not fragmented state systems. Resources may be government-verified or crowd sourced, with authenticity tagging.

2.20. States should formally promote iconic film locations through signage, branding, selfie points, and tourism infrastructure. International examples show high returns from film tourism. Locations should be marked digitally on portals and physically on-site.

2.21. Each State must designate a single nodal department with authority to coordinate all line departments. Filmmakers should interact with only one nodal agency, backed by formal government orders.

2.22. ICH will develop video tutorials and conduct online workshops to train nodal officers of Central and State authorities, along with other stakeholders, for better understanding and effective implementation.

3. Secretary, MIB urged the States & other stakeholders to take expeditious action in regard to the following points:

3.1. Greater use of ICH as a single-window system for permissions and resources is essential to promote Indian cinema, directly supporting tourism and the creative economy. States should incorporate any requirements or changes into the existing portal to avoid parallel systems and ensure convenience for filmmakers.

3.2. There is a strong need to proactively sensitize and onboard domestic production houses—both major and independent—onto the portal to ensure its success. NFDC / ICH may engage with the national associations and major producers to start utilizing the ICH portal. The States may make efforts to engage with the regional filmmaker associations to educate them about utilizing the ICH portal for permissions.

3.3. States should encourage to upload and showcase their pre-production, production, and post-production resources—including studios, crew, artists, VFX, music, and technical services. Where such resources already exist, backward API integration with ICH should be implemented to attract filmmakers.

The meeting reaffirmed the goal of presenting India as a single, film-friendly destination with predictable rules, transparent processes, and discoverable resources. This unified system will enhance investment, employment, tourism, and India's global soft power.

The meeting ended with a thanks to Chair.



## 2J. PRE-APPROVED FILMING LOCATIONS

### **What is unique**


- Filmmakers can apply for filming permissions by merely selecting available dates and paying one-time fee that covers all permissions- With laid down SOP
- Permissions for such locations would be automatically deemed approved, if necessary, documents as prescribed by the state are adhered to.
- Ability to promote famous locations and shooting spots with ease and bank on more projects thereby increasing tourism

### **Ask from states:**

1. Identify 5-6 locations in each state that can be classified as possible pre-approved locations
2. Identify permitting authority for each said location
3. ICH to map the same to locations.

### 3. STATE WISE FILMING INCENTIVES

1. **Madhya Pradesh: International Films:** Grants up to ₹10 crore or 10% of total production cost. **International Documentaries:** Up to ₹40 lakhs
2. **Uttarakhand:** As of January 2026, the state offers subsidies up to ₹3 crore under its new film policy to promote itself as a global production hub.
3. **Delhi:** Provides a tiered incentive ranging from 5% to 25% of QPE, with a maximum cap of ₹30 million.
4. **Uttar Pradesh:** Offers cash grants and subsidies with a cap of ₹20 million for qualifying productions.
5. **Rajasthan:** Under its **Film Tourism Promotion Policy 2025**, the state offers significant financial subsidies of up to ₹3 crore for feature films, along with other benefits such as location fee reimbursements and performance bonuses for award-winning films.




### 3. STATE WISE FILMING INCENTIVES

**6. Jammu & Kashmir:** Provides a **25% rebate** on QPE, capped at **₹20 million**.

**7. Gujarat:** Offers substantial assistance up to **₹75 lakh** for Gujarati films, and incentives up to **₹5 crore** for those securing international awards.

**8. Andhra Pradesh:** Offers a special cash subsidy of **₹10 lakh per film** for low-budget Telugu feature films entirely shot in the state, along with potential GST reimbursements.

**9. Assam, Chhattisgarh:** **25% rebate** on Qualified Production Expenditure (QPE), with caps ranging from **₹1 crore** to **₹2 crore**


